

Use of personal information

If you have given blood in the past, certain information contained in your donor file, such as your communicable disease test results, your blood type and, if applicable, the reason for your exclusion as a blood donor, will be transferred to your research donor file. This is why we ask for your permission to access your blood donor file when you register for the Research Blood Donor Registry.

The information collected about you is kept confidential, in accordance with the law. You may consult your file and have it rectified if need be. To do so, please write to:



To register, you must:

We give priority to registrations from persons excluded from blood donation for transfusion purposes.

► What does joining the Registry involve?

By filling out and returning the included detachable form, you agree:

- ▶ to be registered in the Research Blood Donor Registry;
- to have a Héma-Québec representative contact you to invite you to take part in a study; and
- to have the data collected by Héma-Québec for your blood donor file, if applicable, be included in the Research Blood Donor Registry.

You are free to refuse to take part in a study that is proposed to you. If you agree to participate in it, you will receive all the necessary information and you will have to sign a donation consent form.

You can also withdraw from the Registry at any time by contacting the blood collection coordinator in writing or by phone. Each request is treated confidentially.
